

### Just starting out?

Placing an order for the e-DECA is always a two-part purchase!



- 1. First, you must purchase the Annual License (Item# 16701) at the price of \$249.95.
- 2. Second, you must purchase the ratings you need. This covers either how many ratings you plan on doing <u>OR</u> how many children for which you plan on completing a rating. There are actually FOUR separate options available. *Please note that this does not mean a purchase of the types of ratings (i.e. Infant, Toddler, Preschool); this selection comes later.*

<b>By Assessment Ratings:</b> Also called Single Ratings,	Option #1	Option #3

If you just need to renew your Annual License, simply make the purchase for just the \$249.95 license, Item# 16701.

If you just need more ratings, feel free to place an order for the type of ratings you need (one of the four options previously listed).
